

- Participating employers do not match contributions or have administration responsibilities


2024 Data Collection Tool (DCT) schedule



Payroll-based reporting (PBR) data collection schedule




Annual pension statement timeline: Employers who work directly with CAAT



- Send Pension Benefit Applications
 - Ensures members are set up to receive first pension payment on July 1
- Processed close to 400 June 30th retirements last year
