### Access your up-to-date pension information on My Pension, the CAAT Plan portal

Your member account on My Pension, the new portal, is ready to use. Follow a few simple steps to activate your account, and see your pension information online.

#### To activate your account:

Visit www.caatpension.ca and click on Login.

To start, enter your Member ID (shown below), date of birth, and the last three digits of your social insurance number.

You'll be asked to confirm your email by entering a one-time use verification code, which you'll receive during the login process. Next, set up your secure password and security questions.

When you log in for the first time, be sure to review your data and set up your personal preferences. Then you'll be all set to access your pension information directly from the CAAT Pension Plan.

My Pension makes it easy for you to plan your retirement – see your most recent pension calculation, and earliest retirement dates whenever you want.

Send and receive secure messages about your pension through the Message Centre.


